Procurement of Various Hospital Equipment (Lot 4)

1. The Department of Health, Batanes General Hospital, through the General Appropriations Act (HFEP) CY 2018 intends to apply the sum of PhP1,250,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the whole lot. Bids received in excess of the ABC for the whole lot shall be automatically rejected at bid opening.

2. The Batanes General Hospital now invites bids for the Procurement of Various Hospital Equipment at Basco,

Batanes. Delivery of the Goods is required within one hundred twenty (120) calendar days upon receipt of Notice to Proceed (NTP). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Batanes General Hospital, Administrative Section and inspect the Bidding Documents at the address given below during Office Hours, 8:00am-5:00pm, Mondays - Fridays.

5. A complete set of Bidding Documents may be acquired by interested Bidders on October 24, 2018 from the address at NO COST.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity.

6. The Batanes General Hospital will hold a Negotiation on October 30, 2018 at 3:00 o'clock pm in the BGH Conference Hall, Basco, Batanes, which shall be open to prospective bidders.


7. Bids must be duly received by the BAC Secretariat at the address below on or before November 9, 2018 at 4:00 o'clock in the afternoon. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on November 9, 2018 at 4:00 o'clock pm in the BGH Administrative Building, Basco, Batanes. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Batanes General Hospital, Bids and Awards Committee (BGH-BAC) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
