INVITATION TO BID ITB NO. 2019-02

Supply & Delivery of Various Medicines Subject to Ordering Agreement (Re-bid)

- 1. The Department of Health, Batanes General Hospital, through the General Appropriations Act CY 2019 intends to apply the sum of Lot 2 (CARDIOVASCULAR) PhP638,980.00 being the Approved Budget for the Contract (ABC) to payments under the contract. Bids received in excess of the ABC for the Whole Lot shall be automatically rejected at bid opening.
- 2. The Batanes General Hospital now invites bids for the Supply & Delivery of Various Medicines Subject to Ordering Agreement (Re-bid) at Basco, Batanes. Delivery of the Goods is required within ninety (90) calendar days upon receipt of Purchase Order (P.O.). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding

Documents, particularly, in Sec. of II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from Batanes General Hospital, Administrative Section and inspect the Bidding Documents at the address given below during Office Hours, 8:00am-5:00pm, Mondays Fridays.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on January 15, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, in the amount of PhP500.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The Batanes General Hospital will hold a Pre-Bid Conference on January 15, 2019 at 3:00 pm in the BGH Conference Hall, Basco, Batanes, upon request of prospective bidder/s.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before January 28, 2019 at 3:00 o'clock pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on January 28, 2019 at 3:00 o'clock pm in the BGH Conference Hall, Basco, Batanes. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The Batanes General Hospital, Bids and Awards Committee (BGH-BAC) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
