


The Performance Security shall remain to be valid until the issuance of the Certificate of Project Completion.

"RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT FOR LOT 2, LOT 3 & LOT 4 AND DECLARING FAILURE OF BIDDING FOR LOT 1 FOR THE SUPPLY AND DELIVERY OF VARIOUS MEDICAL EQUIPMENT UNDER ITB NO. 2017-01"

WHEREAS, the Batanes General Hospital (BGH) intends to engage the services of a qualified supplier to undertake the project for the Supply and Delivery of Various Medical Equipment with an Approved Budget for the Contract (ABC) of Lot 1 – PhP2,000,000.00; Lot 2 – PhP6,445,000.00; Lot 3 – PhP3,875,000.00 and Lot 4 – PhP800,000.00 or a total of PhP13,120,000.00;

WHEREAS, Open Competitive Bidding for the above-cited project was conducted in accordance with Republic Act 9184 (RA 9184) and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, Pre-Procurement Conference was conducted on March 1, 2017 to determine readiness of the procurement being undertaken;

WHEREAS, on March 7, 2017, the Invitation to Bid (ITB) was posted in the PhilGEPs Website, BGH Website and conspicuous places in the premises of the Batanes General Hospital continuously for twenty (20) days as well as posted in The Philippine Star in its issue on March 13, 2017;

WHEREAS, Supplemental Bid Bulletin No. 1 was issued on March 7, 2017 to clarify, modify, and amend specific items in the Bidding Documents;

WHEREAS, on March 27, 2017, the Submission, Receipt and Opening of Bids took place as scheduled in the BGH Administrative Building, Basco, Batanes at 2:00 o'clock in the afternoon;

WHEREAS, only one (1) prospective bidder purchased the bidding documents and submitted its bid proposal, namely:

1. LEVINS INTERNATIONAL CORPORATION

WHEREAS, the first envelope containing the Eligibility and Technical Documents was opened in the presence of bidder's representative. The presence, completeness and correctness of the required documents were checked and verified by the BAC using a non-discretionary passed/failed criterion;

WHEREAS, LEVINS INTERNATIONAL CORPORATION was declared "INELIGIBLE" on its proposal for Lot 1;

WHEREAS, LEVINS INTERNATIONAL CORPORATION was declared "ELIGIBLE" on its proposal for Lot 2, Lot 3 and Lot 4 respectively;

WHEREAS, the second envelope containing the Financial Proposal for Lot 2, Lot 3 and Lot 4 of LEVINS INTERNATIONAL CORPORATION was opened and the presence and completeness of the document was verified by BAC;

WHEREAS, on March 28, 2017, the Technical Working Group (TWG) conduct detailed evaluation of the submitted proposals on the Legal, Technical and Financial aspects of the documents of LEVINS INTERNATIONAL CORPORATION;

WHEREAS, on March 29, 2017 – April 7, 2017, the BAC, TWG and End-user Representative convened to conduct post-qualification;

WHEREAS, on March 31, 2017, a letter was forwarded to LEVIN INTERNATIONAL CORPORATION clarifying some issues raised during the conduct of Post-Qualification;

WHEREAS, on April 5, 2017, LEVINS INTERNATIONAL CORPORATION replied on the issues raised and presented their offer;

WHEREAS, on April 6, 2017, LEVINS INTERNATIONAL CORPORATION forwarded their final offer for Item # 3 of Lot 2 – Medical Equipment for Defibrillator with AED function;

WHEREAS, the same were immediately referred to the concerned end-users and they likewise concurred acceptance of the offer of LEVINS INTERNATIONAL CORPORATION;

WHEREAS, as corrected, the bid price for Item # 18 of Lot 2 – Medical Equipment for Suction Machine (Heavy Duty) from PhP180,000.00 to PhP90,000.00;

WHEREAS, on April 7, 2017, LEVINS INTERNATIONAL CORPORATION forwarded a Motion for Reconsideration for Lot 1 (Portable X-Ray Machine);

WHEREAS, on April 7, 2017, the Motion for Reconsideration by LEVINS INTERFNATIONAL CORPORATION for Lot 1 (Portable X-ray Machine) was referred to the concerned end-user and likewise denied acceptance of the offer due to the following reasons:

1. The mA is low which would affect the quality of the image
2. The machine is not motorized which is very basic need when it should have to be brought to the upper floors since the hospital has only ramps for access to this higher levels.

WHEREAS, on April 7, 2017, the TWG submitted the Bid Evaluation and Post-qualification reports indicating therein the results of the technical evaluation for LEVINS INTERNATIONAL CORPORATION stating that the firm complied to the requirements, hence, was recommended for the award of contract at its Submitted Bid Price;

WHEREAS, it was concurred by the BAC Members and TWG to award the contract to IFVINS INTERNATIONAL CORPORATION at its Submitted Bid Price;

WHEREAS, during the preparation and signing of this resolution, there were no pending or unresolved Motion for Reconsideration (MR);

NOW, THEREFORE, on the basis of the above, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the award of contract to **LEVINS INTERNATIONAL CORPORATION** as the Single Calculated Responsive Bid for the Supply and Delivery of Various Medical Equipment for Lot 2, Lot 3 and Lot 4 with a total contract price of **NINE MILLION TWO HUNDRED TWENTY TWO THOUSAND ONE HUNDRED FIFTY PHILIPPINE PESOS ONLY (PhP9,222,150.00)** and to declare **FAILURE OF BIDDING** for Lot 1 (Portable X-ray Machine).
